This is to certify that; **EASL AND MARINE JOBS RECRUITMENT AGENCY** a private registered business operating agency has been licensed to carryout business activities manning or recruitment and placement of seafarers in compliance to Geneva MLC labour conventions of 2006, that Tanzania is part of ratifying member states. The issuance of this license to you in compliance to 2006 ILO and MLC ratified conventions, this agency together with its managing body agree that shall all times bond to observe and comply with the following regulations in all times of its activities execution.

Terms and Conditions of this license:

1. This license shall be durable for only five (5) years in force from time endorsed and it may or may not be renewed if any of the government ratified safe manning regulations attached herewith, shall be breached by any kind of misconducts of any of the licensed agency staff.
2. This license may be ceased any time if any of the licensed agency activities found to be contrary to government shipping and safe manning regulations attached herewith from Part I – IV respectively, and by closure the accountable culprits shall face disciplinary actions and penalties as indicated in Part V of the regulation notice attached herewith.
3. The license holder (holders) accepts to maintain the safe manning minimum criteria for seafarer recruitment and placement service as endorsed by Hon. Minister for transport in United Republic of Tanzania and attached herewith.
4. The licensed manning agency shall also be responsible to crosscheck the requirements of employment or ship flag bearing companies outside the country or region and ensure they comply with ILO / MLC conventions of 2006, and fulfill them. But also to ensure all seafarers hired have valid qualifications and experiences required by the companies.
